



# Trends with the Treatment of Drug Abusing Adolescents with Co-Existing Disorders

Monday, October 6 | 8:30am - 9:15am | Ballrooms C/D

Ken C. Winters, PhD Director, Center for Adolescent Substance Abuse Research

There are several clinical issues regarding the complexity of treating and providing continued care of adolescents with co-occurring disorders. This keynote will provide an overview of clinically-relevant research, with a focus on treating youth who have substance use and co-occurring disorders.

#### About Ken C. Winters:

Ken C. Winters, PhD is a Professor in the Department of Psychiatry at the University of Minnesota, Director of the Center for Adolescent Substance Abuse Research, and a Senior Scientist with the Treatment Research Institute in Philadelphia, Pennsylvania. He received a BA from the University of Minnesota and a PhD in Clinical Psychology from the State University of New York at Stony Brook. His primary research interests are the assessment and treatment of addictions, including adolescent drug abuse and problem gambling. He is on the editorial board of the *Journal of Substance Abuse Treatment* and the *Journal of Child and Adolescent Substance Abuse*, and has received numerous research grants from the National Institute of Health and various foundations. He was the 2008 recipient of the Research to Evidence-Based Practice Award from a national organization on effective treatment for adolescents (JMATE). Dr. Winters is a frequent publisher, speaker and trainer, and he is a consultant to many organizations, including the Hazelden Foundation, The Partnership at DrugFree.Org, National Center for Responsible Gaming, and the Mentor Foundation.



### The Myth of Normal:

Depression, Anxiety and Addictions from a New Perspective

Dr. Gabor Maté, Best-Selling Author and Renown Speaker

For all our progress in understanding and treating mental illness, it continues to be a subject of misapprehension, prejudice and stigmatization. The reason for that may not be its strangeness but its familiarity. Very few individuals or families are not touched by at least some aspects of mental dysfunction, some periods of the discouragement, disconnect or anxiety that, on a deeper and more chronic level, characterizes the mind state of the mentally ill. And beyond individual experience or predisposition, many factors in this stressed and confused culture conduce to mental malfunction on a broad social scale. This presentation will explore the causes and "normality" of depression, anxiety and addictions in our society.

#### About Gabor Maté:

Gabor Maté, MD is a physician and best-selling author whose books have been published in twenty languages internationally. His interests include child development, the mind-body unity in health and illness, and the treatment of addictions. Gabor has worked in palliative care and as a family physician, and for fourteen years practiced addiction medicine in Vancouver's Downtown Eastside. As a speaker he regularly addresses professional and lay audiences throughout North America. He is the recipient of a number of awards, including a Simon Fraser University Outstanding Alumnus Award and an honorary degree from the University of Northern British Columbia. His most recent book, *In The Realm of Hungry Ghosts: Close Encounters With Addiction*, won the Hubert Evans Prize for literary nonfiction. He is an Adjunct Professor in the Faculty of Criminology at Simon Fraser University.


Tonier Cain, Consumer Advocate and Consultant

#### **About Toni Cain:**

Tonier Cain is a consumer advocate who has spoken nationally on trauma, incarceration, and recovery. She has served as a member of the Protection and Advocacy for Individuals with a Mental Illness (PAIMI) Council, a federally required advisory body that reviews and guides work funded under the PAIMI grant and, in conjunction with the Board, sets and approves annual program priorities. She has also worked as a case manager and Director of Advocacy Services for a private nonprofit in Annapolis, Maryland. Ms. Cain is featured in the documentary "Behind Closed Doors: Trauma Survivors and the Psychiatric System." Ms. Cain is the team leader for the National Center for Trauma Informed Care which provides consultation, technical assistance, and training to revolutionize the way mental health and human services are organized, delivered and managed, while furthering the understanding of trauma-informed practices through education and outreach. Ms. Cain is the subject in "Healing Neen," a documentary based on her life as she moved through multiple systems of care.

# **Culturally Competent Mental Health Care for Lesbian, Gay, Bisexual, Transgender and Questioning (LGBTQ) Clients**

This presentation will provide participants with a general overview of how to work with LGBTQ clients in a culturally competent way. Topics will include historical aspects of the LGBTQ community, internalized homophobia and its impact on mental health, family of choice/biological family and intersections in relationships, and working cross-culturally with members of the LGBTQ community.

Donnie has been a National Certified Counselor since 1994. # Walking The Tightrope of Pain Management and Addiction: Using the Addiction-Free Pain Management System

Dr. Stephen F. Grinstead, Doctorate in Addictive Disorders, MA in Counseling Psychology, LMFT, CADAC II, ACRPS, Developer, Addiction-Free Pain Management System

Treatment providers are on the front line to assess, intervene upon and develop appropriate treatment plans for their impaired patients. This becomes more difficult when prescription abuse/addiction is present because of mismanaged chronic pain that is under treated, over treated or misdiagnosed. This presentation will focus on identifying the obstacles this population faces and what it takes to overcome them.

#### About Dr. Stephen Grinstead:

Dr. Grinstead is author of the book *Freedom from Suffering: A Journey of Hope* as well as author of several other pain management books including *Managing Pain and Coexisting Disorders*, and the *Addiction-Free Pain Management Recovery Guide*. He is an internationally recognized expert in preventing relapse related to chronic pain disorders and is the developer of the Addiction-Free Pain Management System. He has been working with pain management, chemical addictive disorders, eating addiction, and coexisting mental and personality disorders for almost 30 years.

### Screening, Brief Intervention, and Referral to Treatment (SBIRT)

is a universal, evidence-based practice used to identify, reduce, and prevent problematic use, abuse, and dependence on alcohol and illicit drugs.

Screening services are provided in a wide variety of settings including primary care community health centers, hospitals, hospital emergency departments, trauma centers, and specialty healthcare centers. The three primary components of services are:

- Screening a healthcare professional assesses a patient for risky substance use behaviors using standard screening tools.
- Brief Intervention a healthcare professional engages a patient showing risky substance use behaviors in a short conversation, providing feedback and advice.
- Referral to Treatment a healthcare professional provides a referral to brief therapy or additional treatment to patients who screen in need of additional services.

#### Recovery Café: A Refuge for Healing and Transformation

## The Hungry Ghost: A Biospsychosocial Perspective on Addiction, from Heroin to Workaholism!

Contrary to what is often claimed, the source of addictions is not to be found in genes, but in the early childhood environment where the neurobiology of the brain's reward pathways develops and where the emotional patterns that lead to addiction are wired into the unconscious. Stress, both then and later in life, creates the predisposition for addictions, whether to drugs, alcohol, nicotine, or to behavioral addictions such as shopping or sex. Helping the addicted individual requires that we appreciate the function of the addiction in his or her life. More than a disease, the addiction is a response to a distressing life history and life situation. Once we recognize the roots of addiction and the lack it strives (in vain) to fill, we can develop a compassionate approach toward the addict, one that stands the best chance of restoring him or her to wholeness and health.
